NOTIFICATION

SUB- Project Closure policy-Corrigendum.

Keeping the homebuyers interest in mind as well as other provisions mandated under the RE (R&D) Act, 2016, the Authority has been pleased to modify Notification No. 4591/ORERA dtd. 03.07.2024 as follows-

1. After completion of the project, a maximum of 1% of the project cost out of balance remaining if any, in the 70% RERA designated Account of the said project will be retained in the same Account for the next five years from the date of issue of the Occupancy Certificate. These funds shall be utilized for repair of structural defects/any other defects in workmanship etc. as envisaged U/s. 14(3) of the Act.

This provision shall be applicable for projects that are developed from funds received from the Allottees.

2. In respect of projects that have been developed from the promoter's own funds, the expenses for such repairs shall be borne by the promoter himself.
3. On completion of the project, the promoter is required to apply to the Authority for closure of the project in a prescribed Application Form as annexed herewith.

The Authority after thoroughly examining the information furnished in the application form shall allow closure of the project subject to fulfillment of all the criteria asked for in the Application Form.

This supersedes earlier Notification No. 4591/ORERA dt. 03.07.2024 issued to this effect.
